(SEC. 1) Participation Agreement

We the parents/guardians of _____ have read the enclosed information concerning the policies of CLUB 80VBC. We agree, having been selected to a team, to let the above named athlete join CLUB 801VBC for the 2022-2023 season.

We have read the information provided and understand the time commitment involved in practice and competition. We agree to the commitments and attend practices, be part of a team, attend all tournaments, and be a great team member, and put in time and work to be successful. We are in contract to pay for ALL fees and tournaments (National teams include Post Season play including nationals). As a team member, I agree to go to ALL tournaments and to uphold the fees for them. If a player chooses not to participate in practices or tournaments, no refund will be given and disciplinary action will take place. My athlete and I have reviewed the fee schedule of this agreement and understand that all fees must be paid in full regardless of the duration of participation by the individual. This includes relocation of the family, or injury. I understand that if for some reason the named athlete quits at some point during the 2022-23 season, we are still liable for all fees until the completion of the season.

(SEC. 2) Photo video and social media release

The undersigned player and parent/guardian hereby authorize Club 801 permission to use photographs or videos of the athlete in any and all its publications, including but not limited to all Club 801 printed and digital publications. We understand that my athlete's photograph media or video will become the property of Club 801 indefinitely. I hereby irrevocably authorize Club 801 to edit, alter, copy, exhibit, publish, or distribute the photo or video for purposes of publicizing Club 801 programs, marketing, or social media.

(SEC. 3) Waiver of Liability

Members agree that CLUB 801 VOLLEYBALL, owners, employees, and staff members shall not be liable for damages arising from personal injuries sustained by the member and/or guest(s), on or about the premises of the said facilities or by participation in events with CLUB 801 VOLLEYBALL. A member will not be able to participate with CLUB 801 until all the following are signed and turned in: **1) Player Contract Agreement 2) Deposit Paid 3) Medical Release Form 4) AAU Registration Fee. 5) USA Membership Fee. 6) Waiver and Liability Release**

(SEC. 4) Payment Schedules

This payment schedule requires the member to pay the team's designated monthly payment which will be due on or before the 5th of each month, beginning with agreeing to the contract, and ending upon the season completion (April-June depending on the team).

A LATE PAYMENT FEE OF \$25.00 APPLIES TEN (10) DAYS AFTER THE DUE DATE. Interest will be charged at 10% a day beginning 15 days after the final scheduled payment is due on the remaining balance. The player will not be able to participate in tournament play, or practice until they are current with their fees.

If I, _____, decide to terminate our involvement with Club 801 Volleyball, I understand I still have an obligation
(Parent/Guardian)

to pay the full amount regardless of injury, status change, moving to a different location or state, or satisfaction level. In the event of default, if this obligation is referred to an attorney and/or collection agency, the member agrees to pay all fees, over and above their liabilities, reasonable attorney fees, court fees, and collection fees. Deposits, and monthly payments to Club801 are non refundable. I also understand I am responsible for the travel fee, regardless of participation or travel.

I have read, understood and agree to the above terms. This contract is not transferable, cancelable by member, and membership is not refundable due to any reason.

CLUB 801 VBC PARENT CODE OF CONDUCT

As a parent(s)/guardian(s) of a member of the Club 801 Volleyball program, I (we) will conduct myself (ourselves) in the manner described below.

1. I understand that I am paying for my child to learn the skills and concepts of volleyball in an effective and respectful environment. Club 801 coaches will provide a role on the team for every player, but my child will not be guaranteed equal playing time in games, matches, or tournaments. Decisions concerning player participation in games and tournaments are solely the responsibility of the coaches to do what is best for the team.
2. My attendance at all practices, team functions and tournaments is expected. Parents and the Player will conduct themselves in a respectful manner by:
 - a. Showing appropriate sportsmanship towards all teams, parents, fans, officials, coaches, and staff. I will refrain from using loud or profane language.
 - b. Being patient and supportive with coaches and athletes, including playing time, regardless of their play.
 - c. Accepting decisions made by coaches and staff.
 - d. Discontinuing behavior deemed unacceptable at the request of staff, coaches, players, officials, or other fans. If parents or spectators related to the athlete fail to honor such a request, it is within the rights of Club 801 staff, or any hosting organization's staff, to request that we immediately leave the event.
 - e. Refraining from distracting, or coaching my child, other players, or coaches during practices or competition.
3. If I have a grievance, I will not discuss my grievance during practice times or on game days. I agree to follow the Grievance Policy and Procedures as outlined in the Club 801 Volleyball Handbook. I will discuss issues after 48 hours of completion of a tournament. I will also look out for my athlete, and the team and make the coaches or 801 staff know of any extenuating circumstances or events that may harm the athlete or team in any way at tournaments.
4. My child must remain at the competition site until released by the team head coach. I am responsible for my child's conduct. I agree I will be financially responsible for all fees assessed relating to my child's participation in Club 801's Volleyball programs, plus any penalties resulting from my failure to meet the terms of this agreement as stated in the Club 801 Handbook and this document. If I remove my athlete before the end of the season for any reason, I am obligated to pay my child's full season fee assessment, as the rest of the team cannot be expected to pick up my share of the team's expenses.
7. I agree to the following consequences if my financial balance with Club 801 is delinquent:
 - a. \$25 late fee after 5 days of stated payment date.
8. I understand the season may be modified due to COVID, and other extenuating situations that the club is responsible to pay for Uniforms, Gym Time Coaches, Travel, Hotel, Tournament registrations, and Insurance up front and prior to attendance. Because different teams attend different tournaments, and no refunds will be awarded.

GENERAL INFORMATION

Welcome to Club 801 VBC! As a club, we are excited for this club season. Your athlete has the opportunity to be a part of something special. To learn life skills. To do something hard. To improve their volleyball skills, work with great coaches and make lots of new friends. Our coaching staff are good people as well as great people to be around. All of our coaches will be trained through the Impact Training Program, as well as specific training related to Club801. They will be instructed in coaching techniques that will produce maximum improvement with effort by the participant and excellence. They will also be trained in “Gold Medal Squared” methodologies. The club will work hard to give you and your athlete an exceptional experience. We are committed to excellence!

We hope you will keep this handbook as a reference throughout the season for many of the questions you may have. It is Club 801 VBC’s hope that this will be a positive and productive volleyball experience for each athlete. Our goal is to further develop skills to help athletes for life, volleyball skills, and encouraging a love for the game.

Club 801 VBC will teach the latest and best individual techniques, and the finest concepts in team play. Our coaching philosophies are based on the most current and thorough research done by world renowned coaches. We will also help your athlete by improving their mental and technical skills. Our program requires dedication and effort and will give you a chance to compete against the top teams regionally and all over the country. The team’s schedule will be based on what’s best for the team. Not what’s best for any other reason.

We strive for a safe coaching and playing environment. All coaches and administration personnel are required to pass a background check and register with AAU prior to the Club’s tryouts. Background checks are required every two years after acceptance.

Club 801 VBC will support the philosophy that volleyball skills of individual athletes would be enhanced if these athletes were given the opportunity to train and compete in volleyball on a year-round basis. We try to provide these athletes with enough volleyball training and competition so that ultimately, we could maximize their opportunity for a possible scholarship at the next level.

The emphasis is on the development of the individual’s volleyball skills while teaching the values of teamwork, responsibility, self-discipline, and self-motivation. While winning is an important team goal, participation by each individual is stressed, with the focus on improvement in **performance** rather than **winning or outcome**.

Every effort is made to identify and locate coaches knowledgeable in the sport. All coaches go through training sessions as well as local and national certifications. We hire great people, and train, and continue education through their tenure with 801

PRACTICES: Practice schedules will be presented to the coaches and the players, and also posted on the club website: www.club801vbc.com. All teams will be starting practices in December and will practice through April or \ May. All teams (11’s – 18’s) will practice twice a week. Practices will be held at the Karl Malone Training Center facility. Team practice times will be finalized after all tryouts have completed (the last tryout is in November)

Every team requires commitment from the players. We expect players to organize their time, so that they can take care of their other responsibilities (homework, jobs, school, etc) without interfering with their responsibilities to Club 801 VCBC for practices, tournaments, travel, fundraising activities, etc. Players and parents must realize that practice is an essential part of the Club 801 VBC program. Coaches must be notified PRIOR to practice if a player cannot make practice. Failure to notify, or missing practices, may result in diminished playing time in tournaments. Punishing athletes by having them miss practices hurts their team.

Club 801 VBC expects that our National team members will make volleyball their priority. If there are conflicts with school or other activities, we expect full commitment for participation to the team..

PLAYER ELIGIBILITY: Players will not be allowed to practice until all forms are completed and turned in along with financial deposit.

A SPECIAL NOTE: Most National tournaments are played on Sundays. This will need to be taken into consideration when making your decisions to commit to our programs. Special arrangements can be made, but that will be between the player, the parents, and the coach. As stated in the Player Contract, payment for Nationals is mandatory, should your team qualify.

COACHING STAFF: Club 801 VBC feels that coaching is the single most important element for your daughter's development in learning life and volleyball skills. We feel we have put together one of the finest and most complete coaching staff in the Intermountain Region. We are looking forward to a great year and the opportunity to work with your daughter.

FEE AND PAYMENT SCHEDULE (deposit due upon completion of tryouts, monthly dates are listed above)

MONTHLY PAYMENTS: DUE AT COMPLETION OF TRYOUTS AND THE 5th STARTING NOV.

Club 801 VBC will make every effort to keep instruction and our "Product" as high as possible and to keep the cost of participation as low as possible. The following are some expenses: practice facilities, coaches, uniforms, equipment, AAU and USA membership (coaches & chaperones), regional tournament fees, national tournament fees, team travel (elite) and miscellaneous expenses for postage, duplication, accounting and bookkeeping services. The Club will sponsor team initiated fund-raising activities which will enable players to earn money towards their expenses. Players are also encouraged to seek sponsors for their club expenses.

EXTRA EXPENSES: Players who participate on certain Club 801 VBC teams (primarily the National teams) may have some extra expenses related to additional tournaments or travel not included in the Club budget and basic Club fee. These extra charges will be billed the month before the event is to occur.

CLUB FEES: Fees are **non-refundable** because they are based on the Club's expenses and the total number of players in the Club. A payment schedule has been established to allow the fee paid over a period of time, rather than entirely at the beginning of the season. The Club reserves the right to require payment in full if a player's fees are consistently not paid when due. Monthly payments are due on the 5th of each month starting in November. Please note that club fees include the **ENTIRE SEASON**, whether your daughter wishes to complete the season or not (subject to the discretion of the Director).

1. In order for the Club to maximize its efficiency in preparing for the club season (ordering uniforms, sending Tournament entry fees, etc.) it is necessary for us to collect the deposit upon acceptance. (Please read over this Parent Manual carefully before attending the parents meeting. We will answer questions that you might have, concerning your decision about joining our Club. If it is not possible for you to pay the deposit amount by the parents meeting, \

Monthly payments are due by the 5th day of each month. Late charges of \$25.00 will be assessed to your account if payment is not received ten days after the due date. Players will also be held out from participating in practices and tournaments until players fees are current. After the 10 days, interest of 10% will incur on the late balance.

3. Clothing orders will not be placed until the deposit has been paid. Delinquent accounts will have further consequences including your athlete being suspended from practice, games, and potential removal from all club rosters.

CLUB COMMUNICATIONS: Information regarding Club activities will be communicated via the coach, website, and posted on our website www.club801vbc.com, and through emails. Exact tournament locations and times for each individual team will be available the week before the tournament, or provided by the coach.

The local AAU website (<https://www.utahclubvolleyball.com/>) lists all tournament information and can be viewed for schedules and starting times.

In addition, the Club may organize a communication system based upon each team having a "team parent" who assumes communication and organizational responsibilities. It is helpful to have at least two team parents to share this responsibility to contact another member of the team or team parent to obtain the needed information. You may also access all practice schedules on the Club's web site and tournament schedules, along with tournament site locations on the local AAU website.

INSURANCE COVERAGE: Each participant is expected to have her own medical insurance coverage which will be the primary insurance to be relied upon in the event of injury during a Club activity. Once registered with the AAU Volleyball, participants are covered by the AAU's sport accident policy on a secondary coverage basis while participating in scheduled, supervised, and approved activities such as practice sessions, games, fundraising activities and tournaments. If a player has sustained an injury in a Club activity, the coach should be notified as soon as possible. If an injury appears serious enough to require a doctor, medical care should be sought immediately. Parents should make a claim for medical expenses to their family medical insurance first. AAU's coverage is secondary.

PARENTAL PARTICIPATION: Club 801 VBC needs and encourages parental participation. At some major events, parents are needed to help with chaperoning, transportation, laundry, etc. Please notify your daughter's coach, or the Club Director if you are interested in becoming a team parent. All chaperones will have to complete a background check and register with USA or AAU Volleyball prior to participating with the team and boys.

RULES AND REGULATIONS OF CLUB 801 VBC AND GRIEVANCE POLICY AND PROCEDURES 1)

When you have a complaint regarding your daughter, we expect you to use the following steps to solve the problem:

1. The athlete should speak with the coach first.

PLEASE TEACH YOUR DAUGHTER OWNERSHIP AND RESPONSIBILITY

2. The parent and athlete should speak with the coach.

3. If the issue is not remedied, the parent and athlete should meet with the coach and the Club Director.

*Players or parents not complying with this procedure risk expulsion from the club.

2) Parents and/or players are expected to call the coach to set up a meeting time away from competition or practice site. A dead period of 48 hours will pertain before discussion of playing time issues. If this type of behavior happens, the athlete involved and the athlete may be dismissed from the club with no refund of the participation fee.

3) It is not appropriate for athletes, or parents, to approach other parents or athletes regarding any problems they may be having with the coach, or any coaching decisions. This type of behavior is rarely positive and not effective for the athlete or the team.

4) Club 801 VBC does not have the philosophy of giving equal playing time during tournaments. Goals are determined by what is best for the team, and athletic goals (mostly winning). Playing time is determined by the performance of the athletes and is left to the discretion of their coach. Competitive teams will try to have more "equal" playing time. Regional and National teams have a higher priority to win than competitive teams and equal playing time will try to be followed.

PLAYER AND PARENT BEHAVIOR: Belonging to Club 801 VBC is a privilege and should not be construed as a right. This privilege can be revoked at the discretion of the Club Director at any time. Club should not, has not, and will not tolerate players or parents or parents who behave in a manner which is disruptive or detrimental to their athlete, the team, coach, or the team.

PLAYER BEHAVIOR: Each player, as a condition to Club membership, agrees to abide by the following rules: 1) Player Code of Ethics: A player is not merely an individual; a player also represents both the team and the Club. A player's conduct reflects not only the coach's training, and the philosophy of the entire Club. A player's actions, because a player is a leader, must be without reproach:

2) A player should:

a. Participate as a member of a team, showing for the team effort.

b. Be concerned primarily with playing, leaving control of other people at an event to the appropriate officials.

c. Show respect for the team, the coaches, and the officials.

d. Realize that successful sportsmanship at a game depends, to a large measure, on a player's actions. Thus a player is courteous on the court as well as on the bench.

e. Make every honest effort to win a contest, but avoid deliberate actions which could cause harm to other players.

f. Maintain acceptable standards of personal appearance.

PARENT BEHAVIOR: The Club recognizes and is understanding of parent emotions related to competitive sports. The major issues which arise relate to team placement of players, playing time, and criticism of coaching decisions and behavior. ***Coaching decisions are not subject to parental interference.*** Parents may make inquiries for clarification, but should not confront the coach on a disagreement. Coaches are not obligated to take abuse which may be acceptable in other organizations. If a coach's behavior is demeaning or detrimental to the welfare of a player, the parent may submit the issue to the Club Director.

CLUB DISCIPLINE: Club discipline is based upon what is best for the player, and in some cases, the Club. The coach is the primary focus of control for discipline. At this level, discipline can remain informal and at a low profile. If it is determined by the coach that steps taken have not remedied the problem, the Club Director may be consulted for assistance.

APPEAL CLUB DIRECTOR'S DECISION: Disputes regarding policy and instructions/directions covered in this handbook are final. Appeals should be made as follows:

- **Appeal:** All other dispute judgments made by the Director must be appealed in writing to the club manager within 5 days of the Director's decision. Appeals will be reviewed, evaluated and brought to a conclusion by a committee composed of the club manager and the elite coaches representing teams (18 – 14). The appeal response will be sent within 5 days..
